- Jami explained that the Genesee District Library is leaving the Mideastern Michigan Library Cooperative and how that will affect the Cooperative and services.
- Alyson Jacobs will be an attending Spring Institute for Youth services in March, and Jami, Linda, Cathy and Danielle are the Lapeer District Library. Both will provide information for improving services for patrons.
- June 2023 ECF funding will end, funding for hotspots. Jami would like to decrease the number of hotspots and redefine the lending polices in June to put in place when the ECF funding is ended.
- Jami will be attending a Perry Parks Committee meeting February 28<sup>th</sup>, and discuss ideas for library's involvement with them.
- Branches have been busy with a full calendar of events and the Neighborhood Forest tree program will return, with patrons receiving a tree seedling to plant.
- Corunna branch has been selected to host a Michigan Notable Book author, this is provided by a grant from the Library of Michigan.
